

## STATEMENT OF THE CANDIDATE FOR A MEMBER OF THE SUPERVISORY BOARD OF PKN ORLEN S.A.

I hereby declare that I agree to candidate to the Supervisory Board of PKN ORLEN S.A. ("the Company") and

- With regard to my person, no statutory prerequisites are met that would prevent me from being appointed to the position of the Supervisory Board member of PKN ORLEN S.A. and from holding such a position, and in particular prerequisites specified in Article 18 and Article 387 of the Commercial Companies Code.
- I meet / do not meet\* the criteria of being independent Member of the Supervisory Board resulting from § 8 item 5 of the Company's Articles of Association:
  - 1) I am not employed by the Company or its Affiliated Party<sup>1</sup>,
  - 2) I have not been a member of the management body of the Company or its Affiliated Party at any point during the five years preceding my appointment to the Supervisory Board,
  - 3) I am not a member of the corporate bodies of the Affiliated Party,
  - I have not received at any point during the five years preceding my appointment to the Supervisory Board any additional remuneration in a significant amount, i.e. in a total amount exceeding six hundred thousand Polish zlotys, from the Company or its Affiliated Party except for the remuneration obtained as a member of the corporate bodies,
  - I have not been a shareholder or employee of the current or previous certified auditor examining the financial statements of the Company or its Affiliated Party at any point during the three years preceding my appointment to the Supervisory Board.
  - 6) I am not a shareholder having 5% or more of votes at the General Meeting of Shareholders of the Company or its Affiliated Party.
  - 7) I am not a member of supervisory or management bodies nor an employee of an entity having 5% or more of votes at the General Meeting of Shareholders of the Company or its Affiliated Party,
  - 8) I am not an ascendant, descendant, spouse, sibling, parent of a spouse of any person specified in the preceding points; nor am I adopted by any person specified in the preceding points,
  - 9) I have not been a member of the Company's Supervisory Board for longer than 3 terms,
  - 10) I am not a member of the management board of the company, in which a member of the Company's Management Board holds a position on the supervisory board of such a company,
